



# **PARTICIPATION & RELEASE AGREEMENT**

## **CPP/YTP – Raise Your Voice Broadway Jr Revue**

### **ALL PROGRAMS, PRODUCTIONS, EVENTS AND ACTIVITIES**

On my behalf, and/or on behalf of the minor(s) named below for whom I am a parent or **legal** guardian ("Participant(s)"), I acknowledge that I have read and understand the information available through the Youtheatre Players and Childrens Playtime Productions web sites and that I have read and explained them to my minor child Participant. I/we agree to comply with the rules, requirements, procedures and expectations that are explained therein and in the handout entitled PRODUCTION HANDBOOK. I/we also agree that we will keep ourselves informed of all information provided in mandatory production meetings, in emails from production staff, and through the castinfo.html website and agree to – as evidenced through continued participation in the program – comply with all further rules and/or clarifications.

**"PHOTO/VIDEO+" RELEASE:** On my behalf, and/or on behalf of the minor-aged Participant(s) named below, I agree that Childrens Playtime Productions ("CPP") (aka Youtheatre Players) may make recordings, including photograph, film, video and/or audio, of the voice, conversation, sounds, and images of Participant in connection with exercises, activities and theatre games, and for rehearsals, performances and other activities undertaken in relation to the above program. I further agree that CPP is and will remain the sole owner of all results and proceeds of such recordings and that CPP and its assignees and licensees may use such recordings and any portion thereof, along with name, likeness and biographical material concerning Participant, forever and throughout the world in all media and in connection with the advertising, publicity and promotion of any such use. I further hereby release and discharge CPP and its assignees and licensees, and the County of Riverside, California, and Pickering Events, of and from any and all claims, demands, or causes of action that I have against them, whether for libel, violation of any right of privacy, or any other matter arising out of or in any manner or connection with the use and exercises of the rights granted to CPP above.

**COVID HOLD HARMLESS AGREEMENT:** I understand that there is no practical way for CPP to completely prevent COVID transmissions among participants or others. In short, COVID still exists and we voluntarily assume the risk that I and/or my children may be exposed to or infected by COVID-19 by attending and participating and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand the risk of becoming exposed to or infected by COVID-19 and other contagious diseases and viruses may result from the actions, omissions, or negligence of myself and others, including, but not limited to, employees, contractors, volunteers, and program participants and their families. The undersigned parent/guardian will agree to defend, hold harmless, and indemnify CPP from any cost, loss, or damages of any type, including attorney fees, to the extent that they arise from the contracting of COVID-19 and any related illnesses and costs or related expenses.

#### **INJURY HOLD HARMLESS AGREEMENT:**

I/we acknowledge that the position as Cast/Staff/Volunteer, regardless of receipt of any forms of compensation, remains an at-will volunteer nature and I/we acknowledge that the producers or directors or Childrens Playtime Productions do not provide Workers' Compensation or other insurance coverage to volunteers. I/we assume all risks association with any and all injuries sustained in the course of my participation in this project. I also acknowledge that, as a volunteer, I may be released at any time, without cause, and without right of appeal.

It is my express intent that the Hold Harmless Agreements herein shall be deemed as a release, waiver, discharge, and covenant not to sue Childrens Playtime Productions (or Youtheatre Players or Youth Take the Stage), including but not limited to its Board of Directors, agents, employees, instructors, assistants, representatives and volunteers. It is my express intent that this Hold Harmless Agreement shall be deemed as a release, waiver, discharge, and covenant not to sue any Event locations including but not limited to The Shops at Palm Desert Mall or its successor company.

Parents (or **legal** guardians) may use this form for to cover up to four individual minor participants. In such case, this form adheres to both the minors and the adult signatories. In the event of a participant(s) 18 years of age or older – please use separate forms for each such adult.
